#### Bitten by the Past

Gifted with an impeccable memory, it patiently bides its time. And then, just the right moment occurs and it springs onto the scene with a deftly-aimed bite to the jugular.

The health insurance reform he defended and signed into law as governor of Massachusetts. And even worse for Mitt? 

#### Tales of a Mountain Democrat

Jeanne wrote to me: "If I were about 20 years younger I would go for it. Not at this ancient age. I voted for FDR!!!!!"

I knew right then that **Jeanne Schaeffer** was somebody I wanted to get to know.

What Jeanne didn't want to "go for" was being an **Obama for America** grassroots activist, but she thought I'd be great at it. I ducked that one, but grabbed her by her little toe and insisted she tell me all about herself.

She began: "Yes, that was a happy day for me when I cast my first vote and I have never changed my mind since then as to which party cares about the people. I am really upset about the unions breaking down. None of those people knows what it was like before unions. I grew up with no health insurance. I doubt anyone had it during those Depression years. There was still child labor in this country before unions. Just like a third world country and like the ignorant people are working to get it that way again. You can't cure stupid, I guess."

Jeanne is a native Californian and became interested in politics in the fourth grade because she saw what the country was like under Coolidge and Hoover. Then the changes came with FDR and she had to wait 'til she was old enough (21) to vote for him. Growing Tales of a Mountain Democrat (continued)

up in San Francisco, a cosmopolitan city with many ethnic groups, made her open-minded and unprejudiced. She was horrified when she saw some of the rest of the country with segregation and bias, and people who were fearful of other cultures and ethnicities.

And what about her mother's politics? "As a kid, I always wondered why my mother wasn't interested in politics or even bothered to vote. It took a long time for me to realize that women didn't even have the right to vote until a year after I was born, so naturally she wasn't brought up to even consider it. My mother raised me as a single parent. She was a legal secretary. By the way, all secretarial jobs were 5 1/2 days, and there was no overtime pay or benefits. No such thing as a 40 hour week!"

One of Jeanne's biggest concerns is education. She states: "A bit of history—The generation before mine knew as much at the end of eighth grade as we knew upon graduating from high school. Now college graduates are lucky if they know what my generation of high school graduates knew. Education is so important and teachers should be compensated as much as other professionals."

Jeanne goes on: "I have traveled lots of the world and, in between, raised my family in an affluent suburb. People were surprised we were not Republicans, as my husband was in management at Hewlett-Packard. We stayed true to our beliefs and were not influenced by his success."

#### **2011 California Democratic Party Convention**

Greetings! I have just returned from the 2011 Convention of the California Democratic Party and offer the following summary as one of your 25th Assembly District Delegates:

The over-arching and recurring themes of the convention were:

- 1) Satisfaction that the Democratic Party in California effectively connected with California voters in 2010 resulting in wins for Democrats in all state constitutional offices and adding another Democrat to the State Assembly.
- \*\*\*Current action needed: Begin voter education and registration cycle for 2012, and contribute to Dem 2012. Go to www.CaDem.org.
- 2) The urgent and compelling need to turn out support for workers and families in California and nationwide.
- \*\*\*Current action needed: Letters to editors and governing officials, call-ins to talk programs supporting workers, rejecting anti-union, anti-worker, and anti-family legislation and budgets. Costa Mesa, CA is the next Wisconsin, with the city council and mayor laying off the public sector union workers in favor of privatized city services.
- 3) The urgent need for extending the Schwarzenegger temporary tax structure in California in order to avoid irreparable harm to education, services, and infrastructure.
- \*\*\*Current action needed: Regardless of party or persuasion all voters need to contact their State Assembly and State Senate members IMMEDIATELY and demand an extension of the existing tax rates. Letting the taxes expire will have irreversible consequences for California. As separate matters to support there is an effort to pass a 1% tax increase on the top 1% income bracket in California, an effort to tax oil that is extracted from California

(as is done in the majority of oil producing states), and an effort to end the death penalty and convert existing death sentences to life without parole.

I attended the Rural, Labor, Children's, and Progressive Caucuses where strategies are developed and actions taken to influence the Democratic Party and elected Democrats.

The Rural Caucus emphasized the need on a local level for support for our workers and their families, the need for local media coverage, and the impacts of an all-cuts budget on rural communities.

The Labor Caucus focused on the assault on workers nationwide and in California, and the need to support public service workers in Orange County.

The Children's Caucus reviewed progress on the lead hazards associated with artificial turf and recognized Caroline Cox and the center for Environmental Health for their work on this.

The Progressive Caucus also focused on labor and budget matters.

Some of the resolutions adopted during the general session were: Support for Planned Parenthood, Support of the California Dream Act, Support for Social Security, Repudiation of the Republican Party Marilyn Davenport Obama/Chimp caricature as Racist, Call for internet Sales Tax Compliance, Opposition to Arizona Anti-Immigrant/Ethnic Studies Bills, Support for Protection of the Oceans, and a resolution supporting the Human Rights and Democracy Movement in Iran.

Highlights of the convention for me were definitely the speeches by Independent Senator Bernie Sanders, and our own Attorney General Kamela Harris.
